The Treaty Commission in Saskatchewan has a mandate to educate the general public about the historic treaties. The Commission also has a broad goal to facilitate the process to improve the livelihood of First Nations people so that they can benefit from the economic boom and experience better economic outcomes.

The challenges before us are well known. In the spirit of the treaties, a renewed relationship based on reconciliation, we invite you to attend this three hour session.

The focus of the working session will be on **Attraction, Employment and Retention of First Nations human resources**. The topic expert will be Mr. Ed Standinghorn, Director of Industry Relations for the Battlefords Agency Tribal Chiefs Inc. Ed will share the story of how a committed small unknown organization in the north-west created some positive results and became a change-maker in a short-time. The Atoskewin Success Centre has raised the attention of many policy makers and the First Nations community. The initiative has been heralded in business magazines and most recently Standinghorn was asked to present the "How To" story to MPs in Ottawa. Come and learn, dialogue and make suggestions for ways to duplicate the success principles of the Atoskewin program.
